Prof.Dr.Astrid Stadler

Prof.Dr.Astrid Stadler completed her PhD in 1988 and qualified as a professor at the University of Freiburg, Germany, in 1993. Since 1994 she has held a chair of private law, civil procedure law, private international law & comparative law at the University of Konstanz, Germany. Her fields of research are civil procedure law (German, European and international) with a focus on collective redress, but also contract law, and property law. She is vice-president of the German Association of Civil Procedural Law and co-editor of the German "Juristenzeitung" (JZ). She is a member of several other academic associations, and from 2012-2016 she was vice-president of the Deutsche Juristentag. She has published several books, approx. 200 articles and has worked as an expert on international conferences and for public regulators and ministries in Europe.



Prof.Dr.BU Yuanshi

Prof.Dr.BU Yuanshi was appointed as a professor at the Albert-Ludwigs-University, Freiburg, Germany in 2006. And since then she holds this chair (International Economic Law with Focus on East Asia). She specializes in German and Chinese Civil and Economic Law, International and Chinese Investment Law, Reception of German Law in East Asia, Intellectual Property Law and Technology Transfer in East Asia, and Arbitration. Before that, she was an Lawyer at Homburger AG, a corporate law firm in Zurich, from October 2004 to January 2007.



Dr.CHEN Jielei

Dr.CHEN Jielei is an Assistant Professor of the Law School, Tongji University. She graduated from University of Rome Tor Vergata and China University of Political Science and Law. She specializes in Roman Law, Guarantee Law, Construction Law, and Theory and History of Civil law. She has published many articles, such as Legal Motivation and Guarantee on Green Building Development on Green Building, 2020, Vol.3; The Roman Law Foundations and Codification of Suretyship on Journal of Comparative Law, 2019, Vol.4, and Primary Discussions on the Land Ownership from the Perspective of the Civil Law System on Roman Laws and Russian Laws, Northern Legal Science, 2015, Vol.51.



Prof.Dr.CHEN Yi

Prof.Dr.CHEN Yi had served as the general coordinator of Tongji University for the Shanghai Automobile Museum project, and had participated in the compilation of the "Auto Archives Expo" series commissioned by the Beijing Automobile Museum. Meanwhile, he engaged in researches on automobile economy, automobile culture etc. During the 2010 World Expo in Shanghai, he participated in the organization and implementation phase of the "World Expo Fuel Cell Vehicle Demonstration Vehicle Support Research" project, and was mainly responsible for the coordination and management of the Expo Fuel Cell Vehicle Demonstration Base. Also, he worked as a visiting professor in the Faculty of Law of the University of Mannheim, Germany, and engaged in cooperative research work on the topic: Measures Taken by the State to Reduce Vehicle Emissions.



Prof.Dr.GAO Xujun

Prof.Dr.GAO Xujun is a Professor of the Law School, Tongji University. He graduated from Free University and Humboldt university, Nankai University and Suzhou University. He specializes in International economic law, WTO law, Commercial law, Sociology of law. Meanwhile, he has published many books and articles, such as Comments on CISG, Chinese University Press. 2017; Research on the Application of Article 72 of CISG on Shanghai International Arbitration Review, 2018 volume; and Research on the European Union's Scientific and Democratic Legislation Guarantee Mechanism: Taking Law Drafting as an Example, German Studies, Volume 1, 2017 etc.



Prof.Dr.Gregor Thüsing

Prof.Dr.Gregor Thüsing is a member of the BMAS (federal ministry of Labor and Social Affairs) Employee Data Protection Advisory Board (June 2020 to December 2020). He had studied at the University of Cologne, and was an research assistant at the university's Institute for Labor and Commercial Law. He graduated from Harvard Law School and has admission to the New York bar. He was the Chairman of the Society for European Social Policy, Deputy Chairman of the Church Labor Court Hamburg from 2003 to 2016, and Deputy Chairman of the Society for Insurance Science and Formation. From 2018 to 2019, he was a member of the "Scientific Commission for a Modern Remuneration System" of the BMG.



Prof.Dr.GU Ying

Prof.Dr.GU Ying is now the director of cadre training department at Shanghai High People's Court. She had received a Doctorate in law from Fudan University. Also, she had once served as a deputy director of Organization Department of Fudan University, a director of Fenglin Street, Xuhui District, and a secretary of Longhua Street.



Prof.Dr.jur.Hans Christian Röhl

Prof.Dr.jur.Hans Christian Röhl had been the Dean of the Law, Economics and Administrative Science Section at the University of Konstanz from 2006 to 2009. And he has become a full professor (Ordinarius) of public law in 2004. Besides, he has been authorized to teach the subjects of constitutional law, administrative law, European law as well as comparative law in Heidelberg since 2002. Before that, he has completed a Doctorate through the Juristic Faculty of the University of Heidelberg ("The Scientific Council") and he had studied mechanical engineering and law in Munich, Heidelberg and Bonn. Meanwhile, he specialises in General, European and international public law, municipal law, law of regulatory authorities. Prof.JIANG Huiling

Prof.JIANG Huiling is the Distinguished Professor of law and dean of the Law School, Tongji University. He graduated from the China University of Political Science and Law, University of Montreal (Canada), specialized in jurisprudence, administrative law, judicial system, and ADR. Before he joined Tongji Law School, he had been a Senior Judge at the Supreme People's Court of the People's Republic of China for more than 20 years.



Prof.Dr.jur.Jochen Glöckner

Prof.Dr.jur.Jochen Glöckner graduated from Albert-Ludwigs-Universität Freiburg, Uni-versità degli Studi di Pàdova/Italy, and the College of Law of the State University of Iowa. After graduation, he has been a Judge at the Court of Appeals Karlsruhe and an Academic Director of the Institute for Building and Construction Law Freiburg e.V. since 2005. And from 2006 to 2008, he had been the Dean of the Faculty of Law at the University of Konstanz. Meanwhile, he specialises in Competition law, Consumer law, Contract law as well as interrelated issues. Prof.Dr.Peter-Christian Müller-Graff

Prof.Dr.Peter-Christian Müller-Graff is Senior Professor for Private Law, Economic Law and European Law at the Heidelberg University Law Faculty, Jean Monnet Professor ad personam and former Dean of the Heidelberg Law Faculty. He is Member of Academia Europaea and Honorary Chairman of the Association of the German Law Faculties. His main research interests comprise European internal market law, the legal order of the economy, European private law, the constitutional law of the European Union and other European international organisations and the international Treaties of the European Union. He has published and edited many books on these subjects, published many articles and commentaries and is editor of the ten-volume Encyclopedia on European Law (Enzyklopädie Europarecht).



Prof.Dr.Matthias Ruffert

Prof.Dr.Matthias Ruffert is a Professor of Public Law and European Law at the Law Faculty of the Humboldt University Berlin since April 2016. He had been a Judge at the Administrative Court of Appeal of Thuringia from 2006 to 2016; a Member of the Thuringian Constitutional Court from 2010 to 2015, and a Member of the Review Board "Jurisprudence" of the Deutsche Forschungsgemeinschaft/German National Science Foundation (from 2010 onwards as spokesperson) from 2008 to 2016.



Prof.Dr.Reinhard Singer

From 2004 to 2020, Prof.Dr.Reinhard Singer has been a Professor for Civil Law, Labour Law, Law of the legal Profession, Family Law and Sociology of Law at Humboldt – University of Berlin. After high school graduation in 1970, he studied in Physics, Mathematics and Law in Stuttgart and Munich, and he completed his doctoral thesis in 1992 as well as his postdoctoral thesis in 1993 in Munich. Also, he had been a Professor for Civil Law, Labour Law, Commercial Law and legal Methods at University of Rostock from 1994 to 2004. After that, he had been a Judge at the Civil Court of Appeals in Rostock from 1996 to 2004. Since 2004, he has been the head of the Institute for the Legal Profession, Humboldt-University of Berlin, and since 2017 he has been a Visiting Professor at the Tongji-University Law School, Shanghai.



Prof.Dr.Rüdiger Veil

Prof.Dr.Rüdiger Veil is a professor for corporate law and capital markets law at Ludwig Maximilians-University, Munich/Germany. He has published numerous books, inter alia on "European Capital Markets Law" and on "Corporate Law", and articles in top ranked journals. He was a member of the ESMA Securities and Markets Stakeholder Group (SMSG) from 2014 to 2018; from September 2016 to December 2018 he was the group's Chair. Rüdiger Veil also advises the German Federal Ministry of Finance with special focus regarding the EU financial markets law. He has acted as an expert for the German, European, Chinese and Russian parliament.



Prof.Dr.WANG Qian

Prof.Dr.WANG Qian is an Associate Professor of the Law School, Tongji University. She graduated from University of Bremen, Nanjing University, University of Göttingen. She specializes in Labor Law and Social Security Law. Meanwhile, she has published many articles, such as Defects and improvement of part-time employment regulations: a case study of McDonald's low salary on Law Science Magazine (CSSCI), Vol. 7, 2007; The concept shaping and practical function of the actual labor right on Present Day Law Science, Vol.5, 2012; The legal system of annual leave in Germany on Deutschland Studien (CSSCI), Vol 2, 2013; On the dismissal based on significant changes in the objective situation on Law Science Magazine (CSSCI), Vol 7, 2019 etc.



Prof.Dr.WU Zhiqiang

Prof. WU Zhiqiang is Vice President of Tongji University, Academician of Chinese Academy of Engineering, National Master of Engineering Survey and Design, Academician of German Academy of Science and Engineering (acatech), Academician of Royal Swedish Academy of Engineering Science and Honorary Fellow of American Institute of Architects (Hon. FAIA). Prof. WU serves as Co-Chair of International Steering Committee of World Planning School Congress, Permanent Member of UNESCO-UIA (International Union of Architects) , Member of Advisory Committee - Creative Economy-United Nations Special Unit for South-South Cooperation, UNDP, Vice President of Urban Planning Society of China, Vice President of China Association of Building Energy Efficiency, and Vice President of China Green Building Council. Prof. WU Zhiqiang achieved his master's degree in urban planning at Tongji University in 1985 and doctor's degree in urban and regional planning at Technical University of Berlin in 1994 with doctoral dissertation "Globalisierung der Großtäte um dieJahrtausendwende" ("Globalization of Metroplis at the Millennium"). Prof. Dr. WU Zhiqiang, a leading urban designer and planner, is devoted to sustainable urban design and AI supported urban planning. He advocates urban design innovation both in practice and in methodology for global urban sustainability. Prof. WU is Chief Planner of World EXPO Shanghai 2010 and Qingdao World Horticultural Exhibition 2014 and the Chief Planner of the Earthquake Placement Plan in Sichuan. Currently Prof. WU is the chief planner of urban design concept for the subcenter of Tongzhou in Beijing.



Prof.Dr.ZHANG Taolue

Prof.Dr.ZHANG Taolue is an Associate Professor of the Law School, Tongji University. He graduated from Tongji University, Peking University and China University of Political Science and Law. He specializes in Intellectual Property Law and Internet Law. Meanwhile, he has published many articles, such as China's Intellectual Property Regime for Innovation on Springer Nature Switzerland AG, 2019; China's new patent commercialization strategy, Journal of Intellectual Property Law & Practice on Oxford Academic, Volume 12, Issue 6, 1 June 2017 etc.
