I. Executives and Emergencies: History and Theory

Questions:

- Which prerogative rights of the king does Locke assume and why?
- Is there a distinct continental European tradition of the state of exception?
- In what way does the US model differ from the European tradition in treating emergencies?
- Is the state of exception inside or outside the law according to Schmitt?
- Why exactly are states of exception so dangerous for constitutional orders?
- How has the executive branch evolved in the US, according to Posner/Vermeule? Do you agree with their account?

II. Executives and Emergencies: Legal and Conceptual Questions

Questions:

- "Embedding Emergency Government in Everyday Constitutional Life" does this thesis also prove true in the case of fighting the Covid-crisis?
- What is the weakness of the German emergency constitution (Notstandsverfassung) according to Grote?

III. Cases of Terror Attacks and Financial Crisis

- Does the pandemic lead to a "state of exception" / "state of emergency"?
- Is the pandemic the "hour of the executive"?
- What role do experts play in the pandemic? Does their influence pose a threat to democracy?

V. Pandemics and Threats to Fundamental Rights vs Violating Rights to Health

Questions/Presentations:

Discuss the following questions analyzing and/or comparing different country cases:

- "Do authoritarian or democratic countries handle pandemics better?"
- How can a "right to health" be constructed according to German constitutional law?
 Why is balancing a "right to health" with (other) fundamental rights so difficult?
- What role does the "principle of proportionality" play in German administrative and constitutional law during the pandemic? Discuss the role of the Federal Constitutional Court and the role of the administrative courts during the pandemic!
- Were/are the restrictions on fundamental rights in Germany unconstitutional?
